

### **SPECIAL ELECTIONS:**

The following special elections will be held at the January 28-29, 2017 State Council meeting to fill the vacancies noted below:

<b>NEA Director – District 9</b> (unexpired term of Barbara Schulman)	Date of election to August 31, 2018
<b>NEA Alternate Director - Seat 2</b> (unexpired term of Ken Tang)	Date of election to August 31, 2018

#### Qualifications for Offices:

A candidate for NEA Director or NEA Alternate Director must be an Active member of CTA and a chapter, if available, and an Active member of NEA for the past two years and be employed in the area to be represented.

Declaration of Candidacy forms are now being accepted for these positions. Declarations must be received, not postmarked, **by 5:00 p.m., January 13, 2017**, in the Governance Support Department, 1705 Murchison Drive, Burlingame, CA 94010. Declarations may also be scanned and emailed to [CTAelections@cta.org](mailto:CTAelections@cta.org) or faxed to (650) 552-5010.

Because the nominations and the elections of these offices will be completed at the same meeting, CTA will not print or distribute any campaign material.

The incumbent is David B. Goldberg	June 26, 2017 to June 25, 2019
<b>NEA Director – District 1</b> The incumbent is Doreen McGuire-Grigg, who is ineligible to run due to term limits.	September 1, 2017 to August 31, 2020
<b>NEA Director – District 3</b> The incumbent is Robert Ellis	September 1, 2017 to August 31, 2020
<b>NEA Director – District 10</b> The incumbent is Bill Freeman	September 1, 2017 to August 31, 2020
<b>NEA Director – District 12</b> The incumbent is Bill Sammons	September 1, 2017 to August 31, 2020

Qualifications for Offices:

A candidate for CTA President, Vice President, or Secretary-Treasurer must be an Active member of CTA, NEA and a chapter, if available.

A candidate for NEA Director must be an Active member of CTA and a chapter, if available, and an Active member of NEA for the past two years and be employed in the area to be represented.
