## Organizing Notes

Election 2012 has come and gone, and Campaign 2012 has drawn to a successful close. Many, many thanks are owed to the volunteers from TAL who worked the phone banks, carried signs, and talked to friends and neighbors about the importance of the vote to our schools, students, and educators. We prevented an additional \$6 billion in cuts to education in the state budget, and we retained our rights as an association to participate in the electoral process. Our stake in that political discussion is monetarily small—overall, labor unions are outspent 15-to-1 by corporate and monies interests—but our influence is important, judging by the array of entities lined up to take away the voice of working people.

Locally, Lancaster School District's Measure L passed handily to bring in \$63 million in funding to renovate and modernize

our local schools and to build a much-needed gymnasium at Endeavour Middle School. Funds will also be used to relieve debt pressure on our district's budget as well.

We look forward to hearing news from our Negotiating Team. The district's financial situation is not yet what we would call rosy, but with the positive results of November's election, we can say with confidence that we have passed the darkest times!

## Contribution Limits on 403(b) and 457 Have Increased!

Contribution Limits to 403(b) and 457 Plans Have Increased for 2013

The IRS has announced cost-of-living adjustments for 403(b) and 457 plan contribution limits for 2013, although catch-up contribution limits remain unchanged. Here are the 2013 limits:

-\$17,500: 403(b) and 457 elective deferral limit (up from \$17,000 in 2012)

-\$5,500: 403(b) and 457 catch-up contribution limit (age 50+) (catch-up contributions are in addition to the annual \$17,500 limit)

Be Informed

A 403(b) or 457 plan can help you save for retirement on a tax-deferred basis and supplement your CalSTRS or CalPERS pension. But don't rely on district vendors or pushy sales reps to steer your investment decisions.
